Furthermore, SEKEM has always highlighted the level of communication between processor and supplier as an important part of a healthy value chain, particularly through extensive social protection schemes and a trustful cooperation

of close and dependable partnership. Now, the new certification can demonstrate even more clearly and believably what that precisely means:

long-term guarantees for organic farmers at stable and guaranteed minimum prices that do not only cover their running costs but also allow for room for development, fair wages for the employees of the textile production plants and work conditions including numerous opportunities for personal development through adult education or artistic courses and free from human exploitation.

## From Egypt to Tokyo's Cat Walks

Produced on the fields of SEKEM's cotton farms in the Nile delta, the initiative's demeter-cotton is woven into fine garments and then shipped by Naturetex (formerly Conytex) to resellers like the atelier of Stimamiglio in Italy. Here, the premium quality garments that so far have been mostly used in textiles for babies and toddlers, are being transformed into fashionable women's wear.

On 5 and 6 April these products will now be shown on the cat walks of the fashion show "Tokyo Midtown" bearing the label "Nathu". Naturetex' managers are eagerly awaiting the interest in organic cotton by fashion resellers following the event.



Beginning immediately, everyone can support the initiative ELIANT directly on its homepage at www.eliant.eu. The new alliance has set out to increase the weight of applied anthroposophic work on the European level. Demeter international is also among the first subscribers to the new venture and part of the alliance. SEKEM has been producing demeter-certified products for years and thereby has alwas been a supporter of bio-dynamic agriculture. Therefore, EU legislation is also of relevance to SEKEM and its suppliers.

The survey and signature collection ELIANT has been organising for several months aims at raising support for the proper development of key European legislation that affects applied anthroposophic work. According to the organisers, there are several legislative regulations relevant to anthroposophic industries: for the access to and the development of anthroposophic medicine, demeter foodstuffs, Steiner pedagogy, or curative education and other initiatives.

The organisers of the European Alliance of Initiatives of Applied Anthroposophy have been working for several years in support of legislation that recognizes the particularities of anthroposophic work. It has now set out to support

this work through the collection of 1 million signatures to signify the political weight of anthroposophic work. ELIANT claims this to be necessary as, for example, demeter international has already lost its licence for distributing baby food without added vitamins. The respective EU regulation stipulates that all baby food has to contain vitamins. Such legislation also has a comparable effect on anthroposophic medicines. Such products need a specific form of registration to comply with the special needs of key anthroposophic concepts and their particular forms of production. ELIANT wishes to raise its voice in support of these and other initiatives of applied anthroposophic work and encourages readers to sign the petition online.
